Fees

Individual Lessons

Paid per term. Based on the number of weeks in a term. Equates to \$40 per lesson. Paid per semester. Based on the number of weeks in a semester. Equates to \$40 per lesson.

Public Holidays – No lessons are scheduled or paid for on Public Holidays.

Trial One off Lesson

A one off lesson can only be booked once and cannot be rescheduled.

At the Lessons

Please arrive for your lesson in a timely manner. A waiting area where parents can sit during the lesson is provided. Due to scheduling constraints, lesson times will not be extended if arriving late.

Lessons & Tuition

Individual Lessons

Lessons are 30 minutes in duration for individual lessons. Lessons are individual. One teacher to one student ratio.

Students are to supply their own Guitar/Ukulele for lessons. An instrument can be supplied only for trial classes.

All teachers hold a valid WWCC and are professional music teachers.

Lessons are taught on a weekly basis and require a minimum commitment of one term. Payment for ongoing lessons is due in full 7 days prior to the start of the term or semester. We accept payment by credit card or electronic funds transfer. Cash is not accepted at our studios, except for payment of books and resources that the teacher may have purchased for you. Tuition fees are non-refundable.

Lessons can be purchased in term blocks (one block at a time) or semester blocks (2 terms). Musical Minds follows the Victorian School Terms.

Mid-term enrolments are possible dependent on availability and are billed for the remaining weeks in the term.

Cancellations / Missed Lessons

To be eligible for a catch-up lesson you must record your absence via text to the Director: Tanya Bethune (0431 425 695) or email to hello@musicalminds.com.au **5pm the day prior to your lesson.** If the required notice isn't given to the scheduled lesson time, that lesson will be forfeited, cannot be rescheduled, or refunded.

Make ups may not be with you regular teacher

Make up classes are valid for the period of your booking (term/semester) purchase, including subsequent school holidays. Make up credits cannot be rescheduled more than once and expire if not used.

Make up classes are 1 per term or 3 per semester. The cancellation policy must be followed in order to be allocated your make up class.

Make ups may be possible during the school holidays.

Refunds for make up or postponed lessons are not possible.

When purchasing a semester block: If a student wishes to cease lessons, a minimum of two weeks' notice is required. For example, if a student decides in Term 1 that they do not wish to continue in Term 2, notice must be given at least two weeks prior to the end of Term 1.

When enrolling in lessons by the term you are reserving and committing to a specific lesson time each week.

Our cancellation policy is a necessity to ensure a stable working environment for our dedicated team of teachers.

In cases of sudden illness, exceptions may be made at the discretion of Musical Minds, if notice was given by SMS or email before 10AM on the day of lesson. Medical certificate from doctor will be required.

Teacher's Cancellation: If your teacher is unavailable for your scheduled lesson, a make-up lesson will be provided. If a suitable make up lesson time cannot be found, then the lesson will be credited towards future lessons. In some cases, a substitute teacher may be provided if a teacher is unavailable or due to illness.

Professional Relationship with Musical Minds

Our teachers are not permitted to provide music tuition privately outside of Musical Minds to current students or family members during the time they work at Musical Minds and for a period of 12 months after their resignation. All lessons must be booked and paid for through Musical Minds booking system.
